Shell yesterday took a big step towards consolidating its position as the largest foreign investor in Qatar by signing a Heads of Agreement (HoA) for a \$6.4 billion petrochemicals complex that would take its feedstock from Qatar's natural gas projects, including ethane from Pearl GTL.
