# RWE profits slump as expected, but divestment plans reduced

German utility RWE on Tuesday reported a 34% year-on-year drop in 2011 net income to €2.5 billion (\$3.3 billion), in line with expectations. But outgoing CEO Juergen Grossman said the company aims to “get through the trough quickly”.
