# EIB loan for Greek LNG terminal expansion

The European Investment Bank (EIB) is to loan Greek gas operator DESFA Eur 40 million (\$54.1 million) to increase capacity at the country's only LNG terminal at Revithoussa near Athens. The investment will help finance construction of a third storage tank at the 5.3 Bcm/year facility, which currently has two 65,000 cubic metre tanks.
